THIS AGREEMENT is made at Northbrook, Illinois this 22<sup>nd</sup> day of June, 19 99, by and between UNDERWRITERS LABORATORIES INC. (hereinafter sometimes referred to as "UL") and

ELEKTRO-SCHALTBAU UND VERTRIEBS-GMBH TRIPS

GERMANY

*(Company Name, City and State for Country if not in U.S.A.)*

(hereinafter sometimes referred to as the "Subscriber").

The term "Subscriber" is used to denote a Company that has entered into a relationship with UL as an "Applicant" (the submitter of a product which is covered under UL's Follow-Up Service), a "Manufacturer" (the manufacturer or assembler of the covered product at whose factory the Follow-Up Service is established), or the "Listee" (the Company whose name is published in UL's Product Directories). The Company herein referred to as the Subscriber may be an "Applicant," a "Manufacturer," or a "Listee," either one or two, or all three. The Subscriber's relationship to UL for any particular covered product for which Follow-Up Service (hereinafter sometimes referred to as the "Service") has been established, is as established by the Application under which that covered product was submitted, and any subsequent Applications. Where obligations pertain to a Subscriber without regard to its specific relationship to UL, the term "Subscriber" is used. Where the obligation results from a specific relationship, the term "Applicant," "Manufacturer," or "Listee" is used as appropriate.

Certain devices, equipment, materials or systems (hereinafter referred to as the "Product" or "Products") manufactured by or for the Subscriber have been or will be submitted to UL for investigation under one of several UL programs such as Listing Service, Classification Service, Recognition Service or Certificate Service and for Follow-Up Service.

**Listing Service** is a program whereby UL determines that a manufacturer has demonstrated the ability to produce a complete end product that complies with UL's requirements.

**Classification Service** is a program whereby UL determines that a manufacturer has demonstrated the ability to produce a product that complies with UL's requirements for the purpose of classification or evaluation with respect to one or more of the following: (1) specific risks only, (2) performance under specified conditions, (3) regulatory codes, (4) other standards including international standards, or (5) such other conditions as UL may consider desirable.

**Recognition Service** is a program whereby UL determines that a manufacturer has demonstrated the ability to produce a component that complies with UL's requirements for use in a complete end product that also complies with UL's requirements.

**Certificate Service** is a program whereby UL determines that a manufacturer or installer has demonstrated the ability to produce or install a product that complies with UL's requirements applicable to field installed systems, or to specific quantities of certain products intended for use at specified locations.

If submitted products are to be found eligible for coverage under one of UL's above mentioned programs, Service is established and the name of the relevant company (the "Listee") and the identification of such covered products will appear in UL's published records. The establishment and maintenance of Service is contingent upon the execution of this Agreement and upon continued adherence to the terms and conditions of this Agreement by all Subscribers who are named in the Application under which the product is submitted.
